The issuance of this special use permit is a courtesy, not an entitlement. Permitted activities must not infringe upon the use or access to the Preserve by the general public.

Permittee can use the area highlighted in the red dashed circles on the attached graphic to set up one small folding table and a maximum of 2 chairs. The table must be located on the improved surface, and may not block or hinder public passage through the area.

Pop-up canopies are not permitted without prior authorization by the City. No staking of anything is permitted.

Amplified sound is not permitted.

All participants must remain on improved surfaces at all times.

Removing or disturbing natural elements including but not limited to rocks, soil, and flora and fauna (living or dead) of the Preserve is prohibited.

Permit Requirements and Representations (Preserve)

General:

The City of Scottsdale hereby grants the permit holder (hereinafter called the "Licensee"), permission to use the facility entitled "Resource" herein, as outlined and solely for the purpose outlined above, subject to the terms and conditions of this Permit contained herein and, if indicated above, any additional terms and conditions attached hereto, all of which form part of this Permit. The terms and conditions of this Permit will not supersede the terms and conditions of any other agreement entered into with the City regarding Licensee's use of this Resource.

Rules and Regulations:

Licensee agrees to abide by the terms and conditions of this Permit, Chapters 20 and 21 of the Scottsdale Revised Code, and specific facility rules, regulations and policies, as applicable. Licensee agrees to comply with all federal, state, county and local laws, ordinances, rules, regulations, and policies pertaining to Licensee's use and the Resource.

Indemnification:

Licensee agrees to the fullest extent permitted by law, to defend, indemnify and hold harmless the City of Scottsdale, its agents, representatives, officers, officials, and employees from and against all allegations, demands, proceedings, suits, actions, claims, damages, losses, injuries, illnesses, accidents, and expenses, including but not limited to attorney fees, court costs, and the cost of appellate proceedings relating to, arising from or out of, or resulting from use of the Resource by the Licensee, its employees, agents, guests, vendors, contractors, subcontractors and the above-listed group. The above defense, indemnity, and hold harmless obligations do not apply to claims resulting from the sole negligence of the City of Scottsdale.

General Provisions:

Licensee understands that this Permit is revocable at any time by the City of Scottsdale Community Services Director or authorized representatives and that it may be terminated immediately for any violation of this Permit.

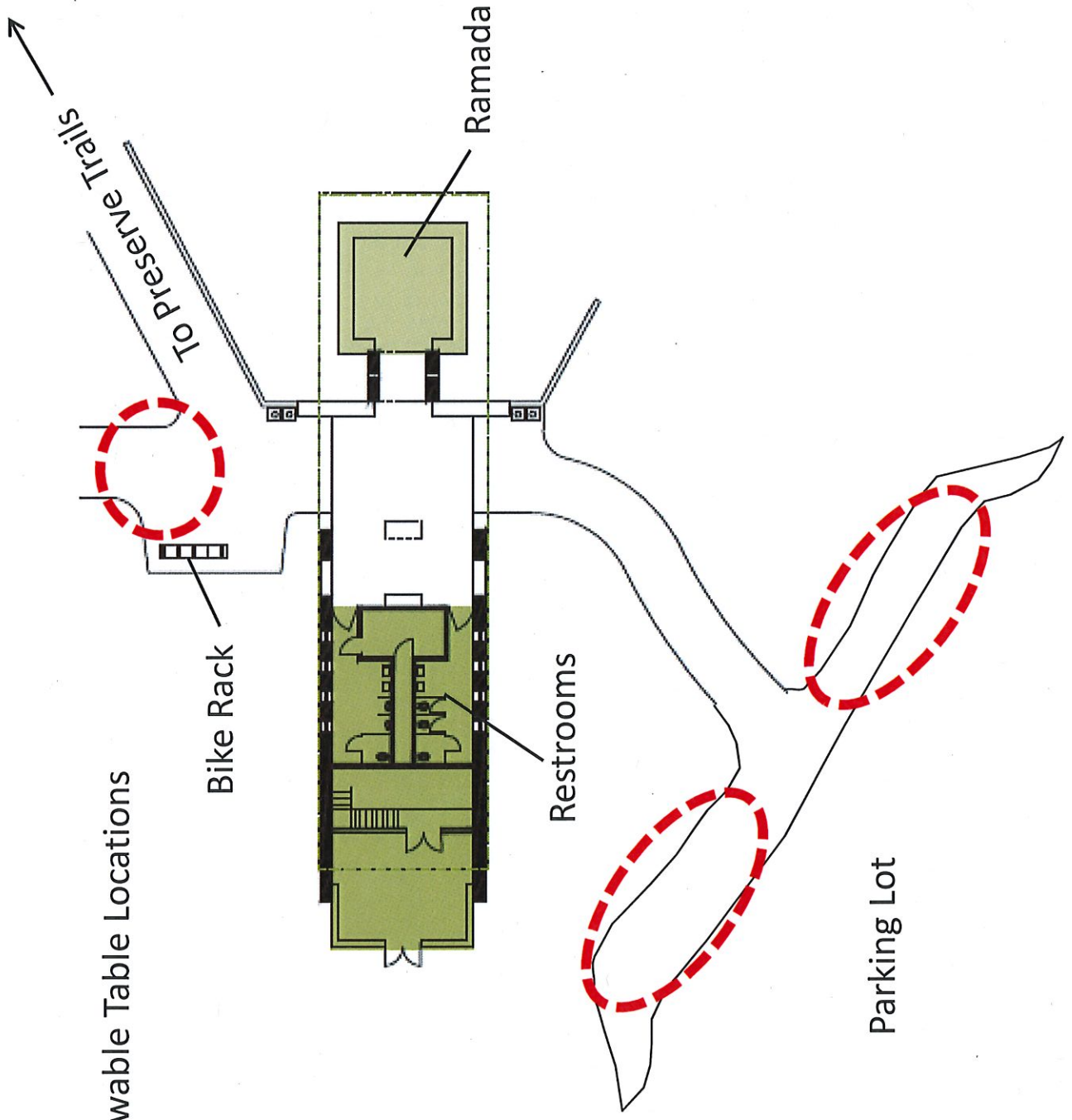

Allowable Table Locations



In recognition of the passionate public debate about the proposed Desert Discovery Center, we have recently received several questions/concerns regarding rules and appropriate behavior when distributing information to those using Scottsdale's McDowell Sonoran Preserve. Following up on information sent out last year, please be aware of the following Preserve rules if you plan to distribute material in the Preserve:

- Please be considerate of trail users and be sure your activities do not infringe on the use or access to the Preserve and trails.
- Speaking to visitors in the Preserve during operational hours is permitted
- Directly handing brochures or flyers to people is permitted
 - Note: commercial advertising flyers, coupons, etc., are not allowed
- You may have a hand carried sign
 - The sign is to be with you at all times and not be placed in front of preserve or city notices
 - No signs are to be staked into the ground, affixed to any building, walls, signage, posts or vegetation
- Anything you bring to the trailhead to express your opinion needs to be removed each day and stored off the preserve.
- Tables and/or tent structures are not allowed - requires permit approval in advance.
- To keep trails and trailheads clean, the McDowell Sonoran Preserve Ordinance (Chapter 21 of the Scottsdale City Code) specifically restricts leaving printed materials (pro or con) at trailheads, accesses and parking areas. Sec. 21-12.b.31 states that printed material:
 - Cannot be placed on cars in parking lots at Preserve trailheads
 - Cannot be placed upon any structure at trailheads, accesses or parking areas
 - This includes brochure racks that are used to distribute official Preserve maps and materials
 - This includes city signs such as those providing public notice about upcoming public meetings

Additionally, if you plan to speak to a large crowd, be aware that:

- No sound amplification systems are allowed in the Preserve (Sec. 21-12.b.30) and,
- Activities with 35 or more people require a permit in advance.

If your organization is handing materials out to people, please make sure that none of it ends up as litter in the Preserve.
